

## **Frequently Asked Questions (FAQs)**

### **Radiography Program Accreditation Status Announcement – Dec. 2025**

#### **1. What does it mean that the program is on probation?**

Probation is an accreditation status issued by the JRCERT when a program is found to be out of compliance with one or more accreditation standards. The program remains accredited while corrective actions are implemented.

#### **2. Is the program still accredited?**

**Yes.** The Radiography Program **remains accredited by the JRCERT** during the probationary period.

#### **3. Will students still be eligible to sit for the ARRT certification exam?**

**Yes.** Students who complete the program while it is accredited remain eligible to apply for the ARRT certification examination, provided all other ARRT requirements are met.

#### **4. Does probation affect current students?**

The program continues to operate and deliver instruction as planned. The probation status does not invalidate coursework completed or degrees awarded during this period.

#### **5. Does this affect future applicants or incoming students?**

Applicants may continue to apply and enroll. The program is required to disclose its accreditation status to all prospective students. All prospective applicants granted an interview for admission into the program had this information regarding the board pass scores disclosed to them.

#### **6. Does this affect financial aid?**

Applicants and current students are still able to apply and utilize financial aid resources. There are no changes or effects to financial aid availability.

## **7. Why was the program placed on probation?**

The JRCERT identified areas where the program did not fully meet one or more accreditation standards during its most recent review. The specific standards cited are being addressed through a formal corrective action plan.

## **8. What steps is the program taking to address the probation?**

The program has developed and is implementing a corrective action plan that addresses all cited standards. Progress reports are submitted to the JRCERT according to established timelines.

## **9. How long will the program be on probation?**

The length of probation varies depending on the nature of the findings and the program's ability to demonstrate compliance. The JRCERT determines when probation is removed.

## **10. What happens if the program does not correct the issues?**

If compliance is not achieved within the required timeframe, the JRCERT may take further accreditation actions. The program is fully committed to meeting all standards to avoid this outcome.

## **11. Will clinical education and rotations be affected?**

**Clinical education continues as scheduled.** The program is working closely with clinical affiliates to ensure educational quality and compliance with accreditation standards.

## **12. Are faculty or program leadership changes required?**

Accreditation actions do not automatically require personnel changes. Any adjustments made will be focused on strengthening program quality and compliance.

## **13. How will students be kept informed?**

Students will receive regular updates through official program communication channels regarding accreditation status and progress toward compliance.

**14. Does probation impact graduate employment or licensure?**

Graduates of an accredited program remain eligible for ARRT certification and state licensure. Employers typically recognize JRCERT accreditation status at the time of graduation.

**15. Where can I find official information about the program's accreditation status?**

Accreditation status is publicly available on the Program's website as well as the JRCERT website.
